Note; We had two new members sign up.

\$ overview;

- 1. Loss of \$1139.35/33Hr=\$33.53 per hour loss. If we take \$33.53/13.35 (ave. Class size) we would need to charge \$2.50/hour more per student to break even.
- 2. IYAMN has been fortunate to have housing donated for the past two Mary and Eddy events. Consideration needs to be given that this may not be the future case. Air B&B three years ago was approx. \$950. For the week.
- 3. There have been comments that I cannot quantify that our events are expensive. When I respond that our highest rate is \$17.88 an hour (non-Member full workshop) they act surprised (to the good). Member rate was \$14.85/hr. full workshop.
- 4. I would like to see registration thru our site and PayPal made a bit easier. 🥕
- 5. We have not paid anything to Barre' Bliss for studio rent. We need to consider this.

rersonal overview takeaway:

- 1. Don't fib to a knowledgeable lyengar teacher about physical issues.
- 2. I feel this was the best workshop Mary and Eddy have done for us. I may be prejudiced as I have always found them to be caring, professional and capable teachers. All questions are answered timely or responded to by email later. It appeared to me that they never paused in attending to student needs, in a style that gave each student personal attention at some point.
- 3. Greeting people at the door is something I enjoy doing, it definitely has a one on one feel to it. At some point during the week there was a palpable change in those attending. I have not felt this before at IYAMN events, but it definitely felt like we built a community this week. Just good people feeling good being with one another. This was a special event for us.

Recommendations;

- 1. Bring Mary and Eddy back next year for another full week. They are holding 10/1 thru 10/7/2018 for us.
- 2. Adjust pricing higher to avoid a loss.
- 3. Change Web/PayPal registration to Member/Non-member full week and weekend only signup with other options only available by mail and check.
- 4. Pay Barre Bliss \$15/Hr x 9.5 hrs= \$142.50 for studio space.
- 5. Tie down studio space for full week ASAP.
- 6. Secure housing as a donation or find reasonable rental.
